RULES AND REGULATIONS

- ✂ Contestant must be a U.S. citizen, a resident of Ohio and a member of a Lake County 4-H Club, Lake County Junior Fair Board, FFA (Future Farmers of America) or the Lake County Farm Bureau.
- ✂ Contestant must be between the ages of 16 and 19 years of age as of January 1, of the contest year.
- ✂ Candidates must be single, never have been married, have had no children, and must not marry nor become pregnant during her reign.
- ✂ Contestant must not have performed any act or engaged in any activity that is or could reasonably be characterized as dishonest, immoral or indecent.
- ✂ A current 5 x 7 photograph of applicant must accompany the application. Photos should not be attached to applications. Photocopies are not acceptable. Photos will become property of the Lake County Agricultural Society and will not be returned.
- ✂ Contest interviews will be held on Saturday, June 6, 2020, at the Lake County Fairgrounds Fair Office. Applicants will be notified as to their interview time. Please dress in business attire.
- ✂ A panel of nonpartisan judges will interview contestants. Interviews will last approximately 15 minutes.
- ✂ Applicants will be judged in the following areas: poise, personality, responses, appearance, presentation and participation in school, community and her organization's activities.
- ✂ NO INTERVIEWS WILL BE HELD AT ANY OTHER TIME OR PLACE.
- ✂ Your appearance is an important part of your overall score. Please dress accordingly.
 - No flip-flops.
 - No bare midriffs or low-cut tops
 - No clothing with advertising logos or inappropriate messages
- ✂ The 2020 Lake County Fair Queen will be crowned at the Queen's Tea held Sunday, June 28, 2:00 p.m.
- ✂ The Queen will receive a crown, roses and a sash, \$100 and other gifts. First-place runner-up will receive a crown, sash, flowers and \$50. Second-place runner-up will receive a crown, sash, flowers and \$25.
- ✂ If the current Queen is unable to complete her reign, the title will be passed to the first runner-up.
- ✂ The Queen and runners-up are required to attend all six (6) days of the 2020 Lake County Fair, held Tuesday, July 28 through Sunday, August 2.
- ✂ They will be required to make appearances, present awards and attend major functions as deemed mandatory by the Lake County Fair Queen Committee.
- ✂ The 2020 Fair Queen will represent Lake County at the 2021 Ohio Fair Managers Association Queen Contest held the first week of January 2021, in Columbus. The Lake County Fair Board will pay expenses for the Queen and one (1) parent/guardian.

- ✿ Completed applications and a photograph must be returned to the Fair Office on or before close of office on May 14, 2020.
- ✿ Applications must be in a sealed envelope.
- ✿ Incomplete or late applications will not be accepted.
- ✿ Judging will be held on Saturday, June 6, 2020 at the Fair Office on the Fairgrounds. Contestants will be notified as to their interview time. This will be the **ONLY** time judging will take place.
