1. OHIO FAIR RACING CONFERENCE EVENTS

a. All "Ohio Fair Fund Stakes" will be raced under USTA rules and Ohio Racing Commission rules with Ohio Fair Racing Conference and local conditions to supersede as advertised.

b. Payments:

March 15 - \$420 for all 21 fairs in the OFRC

Starting Fee: \$100 (Scarlet Division)

2. SIGNATURE SERIES EVENTS

a. 4 Year Olds and up.

b. **Starting fee: \$100**

c. Points are earned for cash prizes and starting in a final at Delaware Fair.

d. If more than 8 declare in, added money (\$3,000) will be split between divisions with starting fee (\$100) to follow.

e. Refer to Huff's Guide for Signature Series Conditions.

3. DECLARATION TIME: 10:00 A.M. EST THREE DAYS BEFORE RACE made through the Ohio Fair Racing Conference Regional Coordinator.

4. Money Division on all races: 50% - 25% - 12% - 8% - 5%.

5. Lasix will be the responsibility of the trainer or owners of each horse.

6. Current Coggins Test (EIA) within past 12 months required.

7. Speed Committee reserves the right to declare off or change program if conditions warrant.

8. The Society assumes no liability in case of accidents.

9. Purse money may be withheld pending return of State lab tests.

10. Blood and urine tests will be collected as required.
